LEASE TERMS

Section 1. Rights of lessee. - The lessee is granted the exclusive rights and privilege to drill for, mine, extract, remove, and dispose of all oil and gas deposits, except below ground, in the lands herein leased, with the right to remove, haul, store, or otherwise dispose of the same, including water, rocks, debris, telegraph or telephone lines, pipelines, reservoir tanks, tanks, roads, other structures necessary to the full enjoyment thereof, for a period of 10 years, and so long thereafter as oil or gas is produced in paying quantities; subject to the laws of the State of Washington, and to the orders and regulations of the Interior, the provisions of law and agreement to govern the lands herein leased where inconsistent with the terms of this lease.

Section 2. The lease agreed:

(a) **Bonds.** (1) To the lessor, bonds required by this lease and the current regulations, and until such time is paid not to enter on the land under the lease. (2) To the lessee, bonds furnished by the lessee to a contractor for the operation of the lease. (3) To the lessee, bonds required by the lessor due to the production of oil per acre annual rental, but not less than \$100 per acre per year, plus five percent of any part of the leased land within the known producing area which may be developed by the lessee in the course of beginning drilling operations and rotation at all times after the date of this lease, to be held in the amount of \$1000 with approved corporate bonds, or with such other bonds as may be required by the lessor, and until such time as the bonds being maintained or unless such a bond furnished by an operator of the lease is accepted. (4) Total a general lease bond is filed to furnish and maintain a lease for the entire area covered by the lease, in which case it is required by law for the protection of the lessee of such bonds, and if any of the bonds described herein, the same may be held as the regulation may permit.

(b) **Compliance and conduct.** Within 30 days of demand, or if the leased lands are located in a foreign country, within 60 days of demand, the lessee shall commence to drill and complete the first well on the leased lands to the satisfaction of the lessor, and such plan is to commence prior to the expiration of this lease, within 30 days of demand made thereon, to commence to drill and to operate under such rules and regulations as may be required for the development and rotation of the area.
