TRUSTEE'S DEED OF SALE SUNNYSIDE RANCH

THIS INDENTURE made April 3 , 1971, between STUART

M. KAPIAN, as Trustee of GREAT WESTERN RANCHES, INC., under
Chapter X of the Bankruptcy Act (hereinafter "Trustee"),
and WEST COAST LIVESTOCK COMPANY, a California corporation
(hereinafter "Purchaser"),

RECITALS

- 1. GREAT WESTERN RANCHES, INC., is a Debtor under Chapter X of the Bankruptcy Act (Action No. B-70-4403 ACW in the United States District Court for the Northern District of California, hereinafter "District Court"), of which the Sunnyside Ranch forms a part.
- 2. The Sunnyside Ranch was transferred to GREAT WESTERN RANCHES, INC. by Stuart and Viola Hammond ("the Hammonds") in return for 15,819 shares of the stock of said corporation.
- 3. Trustee, Purchaser, H. W. Reed, Jack A. Reed and the Hammonds agreed to enter into an agreement relating to the Sunnyside Ranch, conditioned upon the approval of the District Court.
- 4. A Report, Findings of Fact and Conclusions of Law and Recommendation approving the Trustee's application for authority to transfer the Sunnyside Ranch to WEST COAST LIVESTOCK COMPANY was filed March 22, 1971 by the Honorable Lynn J. Gillard, Special Master and Referee in Bankruptcy.
- 5. There being no objections to said Report, Findings and Recommendations, an Order, dated April 2, 1971, confirming sale of the Sunnyside Ranch by the Trustee to the

Purchaser pursuant to said agreement was issued by the Honorable Albert C. Wollenberg, United States District Judge. A copy of said Order is attached hereto, marked Exhibit "A", and is incorporated herein by reference.

 On April 2, 1971, pursuant to said Order of the District Court, said agreement was executed by each of the parties thereto.

NOW, THEREFORE, the Trustee by virtue of the power and authority given in and by an order of the United States District Court for the Northern District of California, dated April 2, 1971, in consideration for the cancellation of indebtedness, withdrawal of claims, and the other considerations described in the aforesaid agreement does hereby convey and release unto the Purchaser, its heirs and assigns, forever, certain real property, commonly referred to as the Sunnyside Ranch, located in White Pine, Lincoln and Nye Counties, Nevada, and more particularly described in Exhibit "B" attached hereto, together with the appurtenances and also all the estate which the said GREAT WESTERN RANCHES, INC. had, at the time of the filing of the petition for reorganization under Chapter X of the Bankruptcy Act in the United States District Court for the Northern District of California, in said premises, and also the estate therein which the Trustee has or has power to convey or dispose of, as Trustee of GREAT WESTERN RANCHES, INC., in said reorganization proceedings.

TO HAVE AND TO HOLD the premises herein granted unto the Purchaser, its heirs and assigns forever.
