This conveyance is made in trust pursuant to and in accordance with "The Samuel A. Hollinger Family Trust", executed on 1971.

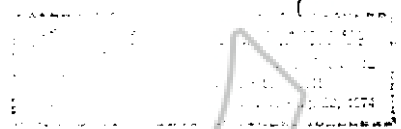
