LOCATION CERTIFICATE
 LODE MINING CLAIM

This is to certify that the lode mining claim named below was located as described below and that the locator thereof claims by right of the original discovery and location and performance of location work in compliance with the general mining laws and the Laws of the State of Nevada, 1500 linear feet along the vein or lode thereof, together with 300 feet on each side of the middle of said vein along the entire length of the claim at the surface and all veins, lodes, ledges or deposits within the boundary lines of said claim.

With respect to this Location Certificate the following facts are presented:

1. The name of the claim is LIZ 21.
2. The name and address of the Locator is: CITIES SERVICE MINERALS CORPORATION, Post Office Box 87, Ely, Nevada.
3. The claim is situated in Section 36, T. 4N., R. 69E., M.D.B.&M., in Lincoln County, State of Nevada.
4. This claim was located on the 9 th day of April, 1971, and the location notice was posted at the point of discovery on said date.
5. The Locator claims 1475 feet easterly and 25 feet westerly from the point of discovery along the general course of the vein which is easterly and westerly.
6. Location and discovery work has been performed by June 30, 1971, as follows: "A pit 18 feet long, 14 feet wide, and 1 1/2 feet deep, located 100' feet 55' from the discovery monument which bears approximately N 82° 0' W 8,206 feet from the SE corner of Section 1, T.3N., R.69E., M.D.B.&M."
7. The claim is more particularly described as follows, to-wit:

From the northeast corner, a monument marked N.E. Cor LIZ 21, thence southerly 600 feet to the southeast corner, a monument marked S.E. COR LIZ 21, thence 750 feet westerly to the south side center, a monument marked S.S.C. LIZ 21, thence 750 feet westerly to the southwest corner, a monument marked S.W. COR LIZ 21, thence 600 feet northerly to the northwest corner, a monument marked N.W. COR LIZ 21, thence 750 feet easterly to the north side center, a monument marked N.S.C. LIZ 21, thence 750 feet easterly to the point of beginning.

The corners of said claim and side centers are marked with 4 x 4 posts in compliance with Chapter 517.030 Nevada Revised Statutes.
