COR LIZ 30, thence 600 feet northerly to the northwest corner, a monument marked N.W. COR LIZ 30, thence 750 feet easterly to the north side center, a monument marked N.S.C. LIZ 30, thence 750 feet easterly to the point of beginning.

The corners of said claim and side centers are marked with 4×4 posts in compliance with Chapter 517.030 Nevada Revised Statutes.
