This is to certify that the lode mining claim named below was located as described below and that the locator thereof claims by right of the original discovery and location and performance of location work in compliance with the general mining laws and the Laws of the State of Nevada 1500 linear feet along the vein or lode thereof together with 300 feet on each side of the middle of said vein along the entire length of the claim at the surface and all veins, lodes, ledges or deposits within the boundary lines of said claim.

With respect to this Location Certificate the following facts are presented:

- The name of the claim is LIZ 167.

- The claim is situated in Section 7, T.3N., R.70E., M.D.B.&M., in Lincoln County, State of Nevada.

- The Locator claims 25 feet northerly and 1475 feet southerly from the point of discovery along the general course of the vein which is northerly and southerly.
- Location and discovery work has been performed by June 30, 1971, as follows: Drill hole No. 1 was drilled on the LIZ 99 claim, at a point from which the SE corner of Section 1, T.3N., R.69E., M.D.B.&M. bears approximately S 46° W, 2,301 feet, which drilling benefits and advances the exploration of the LIZ 99, LIZ 100, LIZ 103, LIZ 121, LIZ 122, LIZ 123, LIZ 165, LIZ 166, LIZ 167, LIZ 168 lode mining claims which are a contiguous group of claims located by the undersigned and which group includes the above named claim.
- The total cost of such work was in excess of \$1,000.00.
- The claim is more particularly described as follows, to-wit:
From the northeast corner, a monument marked N.E. COR LIZ 167, thence southerly 750 feet to the east side center, a monument marked E.S.C. LIZ 167, thence southerly 750 feet to the southeast corner, a monument marked S.E. COR LIZ 167, thence 600 feet westerly to the southwest corner, a monument marked S.W. COR LIZ 167, thence 750 feet northerly to the west side center, a monument marked W.S.C. LIZ 167, thence 750 feet to the northwest corner, a monument marked N.W. COR LIZ 167, thence 600 feet easterly to the point of beginning.

The corners of said claim and side centers are marked with 4 x 4 posts in compliance with Chapter 517.030, Nevada Revised Statutes.
