WHEREAS the Party of the Second Part has for the last past twenty

(20) years supplied electrical power to said mill without cost; and

WHEREAS Lincoln County Power District No 1, a General Improvement

District, supplies said substation with 23,000 volts; and

WHEREAS the power used by the Parties of the First Part is metered separately from the power used by the Party of the Second Part; and

WHEREAS the Parties of the First Part will have more than sufficient power to operate all their present facilities if the Party of the Second Part continues to use said substation:
