

AGREEMENT FOR EXCHANGE OF PROPERTY

WHEREAS, the County of Lincoln, State of Nevada desires to improve a portion of FAS 643 from Elgin north to U. S. Route 93; and

WHEREAS, each of the undersigned is an owner of property along the proposed FAS 643 as re-aligned; and

WHEREAS, the present road now crosses our property and will be abandoned; and

WHEREAS, each of the undersigned has been advised that he is entitled to compensation for the land which shall be used for said road purposes; and

WHEREAS, the County of Lincoln has agreed to abandon the road now traversing our properties which will no longer be used;

we, the undersigned, now agree to convey to the County those portions of our land as disclosed by the final survey now in progress during December 1971 and January 1972 of the Nevada State Department of Highways in exchange for the County Commissioners of Lincoln County abandoning the road now traversing our property without additional compensation.

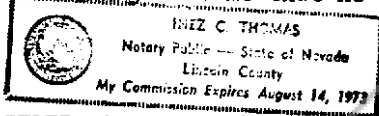

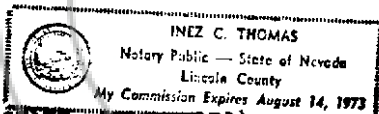

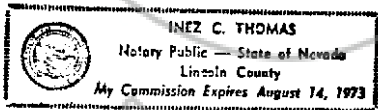
