Situated in the County of Lincoln, State of Nevada:

#### FARCEL I:

The Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of Section 8, Township 2 South, Range 68 East, M.D.M.

Except the right of way deeded to Caliente and Pioche Railroad Co. and also, rights of way deeded to the State of Nevada for highway purposes.
