KNOW ALL MEN BY THESE PRESENTS:

That I, Curtis Poynor of Tom Green County, Texas have named, constituted and appointed and do by these presents name, constitute, and appoint C. B. I expressly stipulate and provide that either said attorneys may act on my behalf in all respects without the joinder of the other and I likewise covenant and agree that those dealing with my said attorneys or either of them, that this power of attorney may be revoked alone by a written revocation executed by me and filed in the office of the County Clerk of Tom Green County, Texas.
