CONTRACT

AND IT FURTHER UNDERSTOOD AND AGREED that if the premises covered.

hereby, or any part thereof, shall be damaged by fire or other
hazards, against which insurance is held, the amounts paid by the
insurance company or companies by reason of such damage, in pursuance of the contract of insurance, to the extent of the indebtedence
remaining unpaid under this agreement, are hereby assigned by the
parties of the second part to the party of the first part.

IF DEFAULT BE MADE in any payment or payments provided for under the provisions of this agreement, the entire amount remaining unpaid shall at once become due and payable without notice, at the option of the party of the first part.

IT IS MUTUALLY AGREED that said payments herein agreed upon shall be made to: JACK FIELDS , Caliente, Nevada, owner of said property.
