JOINT TENANCY DEED

THIS INDENTURE made this 11th day of August A.D. 1972, between Press Lamb and Jane Lamb, husband and wife,

and Roy W. Walch and Sally Walch, husband and wife of Alamo, Nevada,

1972 as joint tenants with right of survivorship, the parties of the second part,

WITNESSETH: That the said parties of the first part in consideration of the sum of Ten dollars (\$ 10.00 ), lawful money of the United States of America, and other and further valuable consideration to them paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT, BARGAIN and SELL unto the said parties of the second part, as Joint Tenants and not as Tenants in Common, and to the survivor of them and the heirs and assigns of such survivor forever, all that certain lot, piece, or parcel of land situate in the

County of Lincoln, State of Nevada, described as follows: A portion of the NE 1/4 of Section 5, T7S., R61E., MDB&M., described as follows: Commencing at the East Quarter corner of said Sec. 5, thence N. 89°05'36" West along the centersection line a distance of 1262.74 feet to a point on the east R/W line of State Highway 93, thence N. 1°10'39" E. along the East R/W line of said Highway a distance of 350.00 feet to the true point of beginning, thence continuing N. 1°10'39" E. along the East R/W line of State Highway 93 a distance of 275.00 feet to a point; thence S. 88°49'21" E. a distance of approx. 800.00 feet to a point; thence S. 17°22'17" W. a distance of approx. 280.15 feet to a point; thence N. 89°05'36" W. a distance of 726.28 feet to a point, being the true point of beginning. This deed is intended to convey the South 275 feet of the grantors property that was conveyed to them by deed from Charles M. Brown and Carma Brown. Said Deed being of record in the office of the County Recorder of said Lincoln County in Book 3 of official records at page 673 to which reference is hereby made.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises together with the appurtenances unto the said parties of the second part as Joint Tenants and to the survivor of them and the heirs and assigns of such survivor forever.
