

QUIT-CLAIM DEED

THIS INDENTURE, made and entered into this 21st day of March, 1973, by and between T. DAVID HORTON of P. O. Box 157, Battle Mountain, Nevada 89820, GRANTOR, and WILLIAM F. WAIKER or NORMA JEAN WAIKER, his wife, of P. O. Box 91, Pioche, Nevada 89043, GRANTEES,

WITNESSETH:

That the said Grantor for and in consideration of the sum of Ten Dollars (\$10.00), current lawful money of the United States of America, and other good and valuable consideration, the receipt whereof is hereby acknowledged to him in hand paid by Grantees, hereby quit-claims and sets over to Grantees all of Grantor's right, title, interest and estate in and to the following described property, in joint tenancy with common law right of survivorship, and not as tenants in common, and to the heirs of such survivor forever, all that certain real property situate in the County of Lincoln, Town of Pioche, State of Nevada, and described as follows, to-wit:

All of Lots numbered Fourteen (14) and Fifteen (15) of Block numbered Twenty-Three (23), said Lots and Block are delineated on the Official Map of the Town of Pioche, State of Nevada, now on file with the County Recorder of said Lincoln County.

TOGETHER with all and singular the tenements, hereditaments, and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the above described premises, together with the appurtenances, unto the said Grantees, in joint tenancy with common law right of survivorship and not as tenants in common, and to the heirs of such survivor forever.
