

JOINT TENANCY DEED

THIS INDENTURE made this 9th day of May A.D. 1973, between

Darrel David Hansen and Verna Schramm Hansen, the parties of the first part,  
and

Clara Garrett and Fannie Cobb, sisters-in-law, of Alamo, Nevada,

as joint tenants with right of survivorship, the parties of the second part,

WITNESSETH: That the said parties of the first part in consideration of the sum of Ten dollars (\$10.00), lawful money of the United States of America, and other and further valuable consideration to be paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT, BARGAIN and SELL unto the said parties of the second part, as Joint Tenants and not as Tenants in Common, and to the survivor of them and the heirs and assigns of such survivor forever, all that certain lot, piece, or parcel of land situated in the town of Alamo, County of Lincoln, State of Nevada, and bounded and described as follows:

Commencing at a point 10 feet south of the Northeast corner of Lot numbered One (1) in Block Numbered thirty-six (36) Alamo townsite, thence continuing South along the street line a distance of 100 feet, thence at right angles West 150 feet, thence at right angles North 100 feet, thence at right angles East 150 feet to the place of beginning.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises together with the appurtenances unto the said parties of the second part as Joint Tenants and to the survivor of them and the heirs and assigns of such survivor forever.

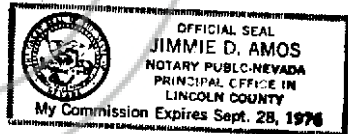

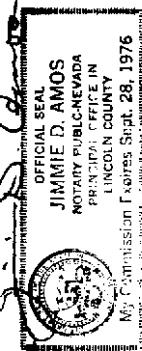
