RESOLUTION OF ACCEPTANCE

WHEREAS, the state of Nevada desires to relinquish a portion of the state highway system as more particularly described on Exhibit "A" attached hereto and made a part hereof; and

WHEREAS, the County of Lincoln is desirous that the said highway be relinquished to the County of Lincoln, pursuant to the provisions of NRS 408.997.

NOW THEREFORE, BE IT RESOLVED by the county commissioners of the County of Lincoln, Nevada that the County of Lincoln does hereby consent to the State of Nevada Department of Highways, through its board of directors, relinquishing to the County of Lincoln that highway shown on Exhibit "A" and more fully described as follows:

Situate, lying and being in the County of Lincoln, State of Nevada, and more particularly described as being a portion of the W 1/2 of the SE 1/4 and the SW 1/4 of the NE 1/4 of Section 32, T. 6 S., R. 61 E., M.D.B. & M., being a strip of land one hundred feet in width, fifty feet wide on each side of the following surveyed highway centerline:

BEGINNING at the intersection of the centerline of U.S. 93 (State Route 7) at Highway Engineer's Station "C" 55 + 78.46 P.O.C. and the left or westerly highway right-of-way line of present U.S. 93 (State Route 7) at a point 100 feet left of and measured radially from Highway Engineer's Station "C" 792 + 49.12 P.O.C., said point of beginning further described as bearing N. 52° 40' 19" W., a distance of 1738.41 feet from the southeast corner of Section 32, T. 6 S., R. 61 E., M.D.B. & M., thence from a tangent which bears N. 18° 01' 36" W., curving to the left along said centerline, with a radius of 2000 feet, through an angle of 0° 58' 45", an arc distance of 34.18 feet to a point; thence N. 19° 00' 21" W., continuing along said centerline a distance of 646.95 feet to a point; thence from a tangent which bears the last-described course, curving to the right along said centerline, with a radius of 1500 feet, through an angle of 8° 37',

an arc distance of 225.58 feet to Highway Engineer's Station Equation "C" 64 + 85.17 P.T. = "N" 70 + 48.20 P.O.T., thence N. 10° 23' 21" W., continuing along said centerline a distance of 1035.09 feet to a point, thence from a tangent which bears the last-described course, curving to the left along said centerline, with a radius of 2000 feet, through an angle of 36° 57' 32", an arc distance of 1290.11 feet to the point of ending at an intersection of said centerline with the north boundary of the SW 1/4 of the NE 1/4 of said Section 32, at Highway Engineer's Station "N" 93 + 73.40 P.O.C., said parcel contains an area of 7.42 acres, more or less.

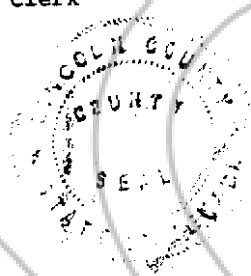
