

RESOLUTION ABANDONING STATE HIGHWAY RIGHT-OF-WAY

whereas, the State of Nevada Department of Highways presently holds all of that certain highway right-of-way for a portion of old U.S. 93 (State Route 7). Said right-of-way is not occupied by the present U.S. 93 alignment; and

WHEREAS, said right-of-way so granted and held is an easement for highway purposes; and

WHEREAS, said right-of-way is of no contemplated use by the State of Nevada Department of Highways due to that portion of old U.S. 93 having been superseded by relocation along a new route; and

WHEREAS, that portion of highway to be abandoned is depicted in red on Exhibit "A" attached hereto; and

WHEREAS, the Department of Highways may, pursuant to NRS 408.996, abandon by resolution any portion of a state highway which has been superseded by relocation.

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the Department of Highways of the State of Nevada, that the following described right-of-way and incidents thereto be and hereby is abandoned; said right-of-way to be abandoned described as follows:

Situate, lying and being in the County of Lincoln,
State of Nevada, and more particularly described as being a
portion of the E 1/2 of the NE 1/4 of Section 19, T. 6 S., R. 61
E., M.D.B. & M., being a strip of land one hundred feet in width,
fifty feet wide on each side of the following surveyed highway
centerline:

BEGINNING at the intersection of the centerline of U.S. 93 (State Route 7), as construction on

Contract 407, and the south boundary of the NE 1/4 of Section 19, T. 6 S., R. 61 E., M.D.B. & M., said point of beginning further described as bearing west 166.79 feet from the east quarter corner of said Section 19, thence N. 12° 20' 00" W., along said centerline of U.S. 93 a distance of 2683.89 feet to the point of ending at an intersection with the north boundary of said Section 19, said parcel contains an area of of said Section 19, said parcel contains an area of 6.16 acres more or less, as acquired by document number 10425, filed in the office of the Lincoln County Recorder, Pioche, Nevada, in book D-1, page 494, on July 16, 1935.
