

JOINT TENANCY DEED

THIS INDENTURE made this day of May A.D. 19 73 , between Paul Stewart and Ethel B. Stewart, husband and wife, and Leo Stewart,

and Harry Jordan and Genevieve Jordan, husband and wife, and Clarence Cox, all of Alamo, Nevada,

as joint tenants with right of survivorship, the parties of the second part,

WITNESSETH: That the said parties of the first part in consideration of the sum of Ten dollars (\$ 10.00), lawful money of the United States of America, and other and further valuable consideration to paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT, BARGAIN and SELL unto the said parties of the second part, as Joint Tenants and not as Tenants in Common, and to the survivor of them and the heirs and assigns of such survivor forever, all that

certain lot, piece, or parcel of land situate in the town of Alamo, County of Lincoln, State of Nevada, and bounded and described as follows:

Beginning at a point 10 feet south of the Northeast corner of Lot 1 in Block 36 of Alamo town, thence running at right angle West 150 feet to the place of beginning, thence continuing West a distance of 87.5 feet to the ditch right of way line, thence running South 116 feet, thence running at right angle East 237.5 feet to the west line of 1st East street, thence north along the west line of said street 16 feet, thence at right angle west 150 feet, thence at right angle North 100 feet to the place of beginning.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises together with the appurtenances unto the said parties of the second part as Joint Tenants and to the survivor of them and the heirs and assigns of such survivor forever.

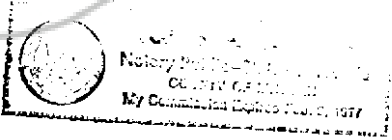
