as Joint Tenants with right of survivorship, as Grantees.

WITNESSETH: That the said Grantors in consideration of the sum of  
Ten and no/100 - - - - - Dollars (\$10.00 ),  
lawful money of the United States of America, and other and further  
valuable consideration to them paid by the said Grantees, the re-  
ceipt whereof is hereby acknowledged, do by these presents, GRANT,  
BARGAIN and SELL unto the said Grantees, as Joint Tenants (and not  
as tenants in common) and to the survivor of them and the heirs and  
assigns of such survivor forever, all of the right, title and inter-  
est of Grantors in and to that certain real property situated and  
particularly described as follows:

The North 199 feet of Lot Two (2) in Block Eighteen (18) in Pan-  
aca, Lincoln County, Nevada, further described as: commencing at  
the northeast corner of said lot, thence running south along the  
street line 199 feet, thence at right angles west 264 feet, thence  
north along the west boundary of said lot 199 feet to the northwest  
corner of said lot, thence east 264 feet to place of beginning; to-  
gether with any and all improvements situated thereon and also one  
(1) share of water in Panaca Irrigation Company.

TOGETHER WITH the tenements, hereditaments and appurtenances there-  
unto belonging or in anywise appertaining, and the reversions, re-  
mainders, rents, issues and profits thereof.
