JUDGMENT

The Plaintiff appearing upon the affidavit of one of its officers and by GLADSTONE & ZUCKER, its attorneys, the Defendants GORDON BAKER and RETA BAKER not appearing though duly and served with summons and complaint in the County of Lincoln, State of Nevada; and the Court having examined the file finds that it has complete jurisdiction of this action and of the Defendants and that no appearance by or on behalf of the Defendants have been made and their default has been duly entered. Upon examining the said Affidavit and its supporting exhibits, the Court finds that the Plaintiff is entitled to the relief herein prayed for. The court further finds that the Defendants GORDON BAKER and RETA BAKER are jointly and severally indebted to the Plaintiff: On their first cause of action in the sum of \$4,406.38, together with interest thereon at the rate of 10% per annum from and after June 4, 1970, now amounting to \$1,457.12 or a total of \$5,863.50; and on its second cause of action in the sum of \$249.61 together with interest thereon from and after August 23,

1 1972, at the rate of 1.5% per month now amounting to \$48.52 or
2 a total due thereon amounting to \$298.13; and that Plaintiff is
3 entitled to judgment for such total amounts, And the Court being
4 fully advised,

5 IT IS HEREBY ORDERED, ADJUDGED AND DECREED That the Plain-
6 tiff FIRST NATIONAL BANK OF NEVADA is hereby granted and awarded
7 judgment on its First Cause of Action against the Defendants
8 GORDON BAKER and RETA BAKER jointly and severally in the sum
9 of \$4,406.38, together with the sum of \$1,457.12 as interest
10 accrued thereon to this time at 10% per annum from and after
11 June 4, 1970, and that the total of all thereof being the sum
12 of \$5,863.50 shall draw interest at 10% per annum from the date
13 of this judgment.

14 IT IS FURTHER ORDERED, ADJUDGED AND DECREED That the Plain-
15 tiff FIRST NATIONAL BANK OF NEVADA be and is awarded and granted
16 judgment against the Defendants GORDON BAKER and RETA BAKER
17 on its Second Cause of Action for the sum of \$249.61 with
18 interest to date in the sum of \$48.52 making a total due thereon
19 of \$298.13, together with interest thereon from and after the
20 date of this judgment at the rate of 1.5% per month.

21 IT IS FURTHER ORDERED, ADJUDGED AND DECREED That the Plain-
22 tiff is entitled to its attorney fees herein which are hereby
23 fixed, allowed, and awarded in the sum of \$ 500.00 ,
24 and the Defendants are hereby ordered to pay the same in addition
25 to the costs of this proceeding which have heretofore been paid
26 by the Plaintiff in the amount of \$50.50.
