WITNESSETH that the said Grantor in consideration of the sum of Ten Dollars (\$10.00) lawful money of the United States of America and other and further valuable consideration, the receipt whereof is hereby acknowledged, does by these presents GRANT, BARGAIN and SELL unto the said Grantee and to its successors and assigns forever, all of the right, title and interest of Grantor in and to that certain real property situated and particularly described as follows:
