Subject, however, to all taxes and assessments due or accruing from and after July 1, 1973.

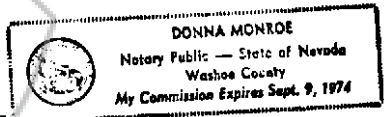
