North, Range 67 East, M.D.B. & M.

To have and to hold the said property granted unto
the said Grantee, and assigns forever, as fully and
completely as I, the undersigned Trustee, by virtue of
the power and authority so vested in me, might or could
sell and convey the same.





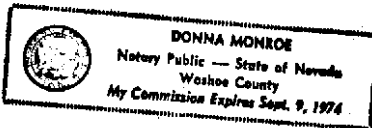
