QUITCLAIM DEED

2 THIS INDENTURE made this 8 day of November, 1973, between EDWARD
 3 STEWART, a single man, of Alamo, Lincoln County, Nevada, as Grantor,
 4 and GLORIA DAWN SURAK, Guardian of the Estate of PHILLIP EDWARD
 5 AMMAR and CRAIG STEVEN AMMAR, Minor Children, of Alamo, Lincoln
 6 County, Nevada, as Grantee:

7 WITNESSETH that the said Grantor in consideration of the sum of Ten
 8 Dollars (\$10.00) lawful money of the United States of America and
 9 other and further valuable consideration, the receipt whereof is
 10 hereby acknowledged, does hereby release and forever QUITCLAIM unto
 11 the Grantee and to her successors and assigns forever all of the
 12 right, title and interest of Grantor in and to that certain real
 13 property situate and more particularly described as:

14 A portion of the Northeast Quarter of the Southwest Quarter (NE/4
 15 SW/4), Section 8, Township 7 South, Range 61 East, MDB&M, in
 16 Pahranaagat Valley, Lincoln County, Nevada, described as follows:
 17 Commencing at the south quarter corner of said Section 8; thence
 18 north along the east line of said southwest Quarter (SW/4) a distance
 19 of 1388.55 feet; thence north 86°41'10" west a distance of
 20 16.03 feet to the True Point of Beginning; thence continuing north
 21 86°41'10" west a distance of 406.62 feet; thence north 0°02'55"
 22 west a distance of 528.72 feet; thence south 89°34'49" east a distance
 23 of 406.40 feet; thence south a distance of 549.25 feet to
 24 the true point of beginning, said parcel containing 5.0256 acres,
 25 more or less, together with any and all improvements situate
 26 thereon.

27 TOGETHER WITH the tenements, hereditaments and appurtenances there-
 28 unto belonging or in anywise appertaining, and the reversions, re-
 29 mainders, rents, issues and profits thereof.

30 TO HAVE AND TO HOLD all and singular the said premises together
 31 with the appurtenances unto the Grantee and to her successors and
 32 assigns forever.

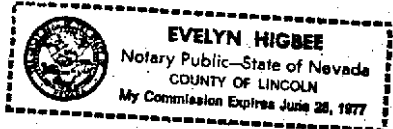
