

SURVEYOR'S STATEMENT

PHILIP C. HULSE states he is a Registered Land Surveyor, State of Nevada and County Surveyor of Lincoln County, and has been employed by PIOCHE MINES CONSOLIDATED INC. to prepare this map of BLOCK 17 in the Town of Pioche, Lincoln County, Nevada. The purpose of said survey and map to locate the exact position of a parcel of land described as a portion of the BALTIMORE LODE CLAIM lying within the following described boundaries:

Commencing at Corner No. 1, from which the SW Cor. of the said BALTIMORE LODE CLAIM bears S74°57' W 355.0'; thence S89°04'E 200.0' to Corner No. 2; thence N0°56'E 120.0' to Corner No. 3; thence N89°04'W 200.0' to Corner No. 4 from which the NW Cor. of the BALTIMORE LODE CLAIM bears N52°36'W 274.4'; and thence S0°56'W 120.0' to Corner No. 1, the place of beginning. 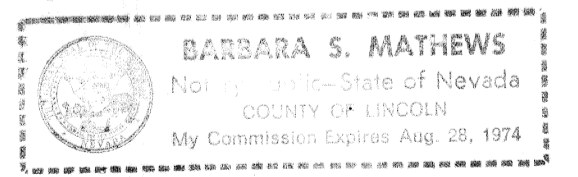
