JUDGMENT

In this action the Defendant, ALTON CLARK BINGHAM, having been regularly served with process and having failed to answer or otherwise appear, the Default of said Defendant having been entered, and evidence by Affidavit having been presented to the Court in support of Plaintiff's claim alleged in the Complaint,

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED, that Plaintiff recover from Defendant, ALTON CLARK BINGHAM, the sum of TWO THOUSAND THIRTY SEVEN DOLLARS AND FORTY ONE CENTS (\$2,337.41), together with interest on said amount at the rate of 14 a month from November 2, 1972 until December 12, 1973, in the amount of THREE HUNDRED ELEVEN DOLLARS AND FIFTY SIX CENTS (\$311.56), together with interest accruing on the total of those two amounts, TWO THOUSAND SIX HUNDRED FORTY EIGHT DOLLARS AND NINETY SEVEN CENTS (\$2,648.97), at the rate of 7% per annum from the date of this judgment until paid.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that the Plaintiff recover from Defendant, ALTON CLARK BINGHAM, attorneys fees in the amount of \$ 500.00 and costs and

1 disbursements in the amount of FORTY TWO DOLLARS AND FIFTY CENTS  
2 (\$42.50).
