Witnesseth: That the said parties of the first part, in consideration of the sum of Ten and no/100- dollars, lawful money of the United States of America, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do presents grant, bargain, and sell unto the said parties of the second part, in joint tenancy and to the survivor of them, and to the heirs and assigns of such survivor forever, all

Certain lot, piece or parcel of land situate in the County of Lincoln, State of Nevada and bounded and described as follows, to-wit:
