# CERTIFICATE OF LOCATION

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a South direction, and 10 feet in a North direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a post five feet high, inscribed "NW Corner of the Red-D #32 Claim;" the southwest corner is marked by a post five feet high, inscribed "SW Corner of the Red-D #32 Claim;" the southeast corner is marked by a post five feet high, inscribed "SE Corner of the Red-D #32 Claim;" the northeast corner is marked by a post five feet high, inscribed "NE Corner of the Red-D #32 Claim." There is also a post at the center of each side line.

The monumentation and marking of the corners was completed by the 20th day of March, 1974  
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
