We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a North direction, and 10 feet in a South direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a post five feet high, inscribed "NW Corner of the Red-D #36 Claim;" the southwest corner is marked by a post five feet high, inscribed "SW Corner of the Red-D #36 Claim;" the southeast corner is marked by a post five feet high, inscribed "SE Corner of the Red-D #36 Claim;" the northeast corner is marked by a post five feet high, inscribed "NE Corner of the Red-D #36 Claim." There is also a post at the center of each side line.
