JUDGMENT AND DECREE OF DIVORCE

THIS CAUSE came on regularly this day to be heard before the Court sitting without a jury upon the verified complaint of plaintiff and all the records and files in this case; plaintiff appeared in person and by and through her attorney, James L. Wadsworth; defendant was not present in person, but heretofore caused to be filed his duly acknowledged Answer in proper person, authorizing the Court to proceed with the hearing of this action without further delay or notice; and the case being at issue.

WHEREUPON evidence was produced by plaintiff in support of the allegations contained in her complaint from which it satisfactorily appears, and the Court finds, that all of said allegations are true; plaintiff's resident and good faith thereof were proved and corroborated as required by law, and the Court is fully advised as to the law and facts in the premises.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

That the bonds of matrimony now and heretofore existing between

1 plaintiff, MINERVA M. BUCKLEY, and defendant, EMMETT BUCKELY be,
2 and the same are hereby, wholly dissolved and held for naught, and
3 said plaintiff is hereby awarded an absolute and final Decree of
4 Divorce from said defendant upon the ground of incompatibility and
5 each of the respective parties is hereby restored to the status of
6 a single and unmarried person.

9 That the community property belonging to the parties shall be, and
10 it is hereby, awarded as follows: the mobile home is awarded to
11 the defendant and he is ordered to assume payments thereon; the
12 1968 Impala automobile and Lots 1, 2 and 3 in Block 44, Pioche,
13 Nevada, are awarded to the plaintiff and she is ordered to assume
14 payments on the automobile.

17 The plaintiff is hereby ordered to pay the community debts of the
18 parties with Allen's cash Store, Stop & Shop and Sears-Roebuck;
19 the defendant is hereby ordered to pay all his separate and person-
20 al debts and all other debts not specifically mentioned herein.
