

RESOLUTION OF BOARD OF COMMISSIONERS OF LINCOLN COUNTY
STATE OF NEVADA, ACCEPTING FEDERAL GRANT OF
RIGHT-OF-WAY FOR PUBLIC HIGHWAY

WHEREAS, there recently has been a large increase in the level of mining exploration activities in Lincoln County, Nevada; and

WHEREAS, the owners of substantial mining interests in the Tempiute Mining District of said county have informed this Board of Commissioners that they are prepared and committed to commence active mining operations in the immediate future; and

WHEREAS, this Board finds that the extension of the county's road net work as hereinafter provided will facilitate access to mining properties and ore bodies in the Tempiute Mining District, and the exploration, development and operation of such mines and ore bodies; and that the transportation of mineral products therefrom to markets will thereby be facilitated; and

WHEREAS, this Board finds that the best interests of the County of Lincoln, State of Nevada, and the inhabitants of said county and state will best be served by extending the county's road network as hereinafter provided;

NOW, THEREFORE, BE IT RESOLVED: That, pursuant to Section 932 of Title 43, United States Code; Section 2822.1-1 of Title 43, Code of Federal Regulations; and Section 403.420 of Nevada Revised Statutes, this Board of County Commissioners does hereby accept the grant of rights-of-way for the construction of highways over the public lands of the United States not reserved for public purposes, as delineated in red on the map hereto annexed as Exhibit A, and hereby by reference incorporated herein.

FURTHER RESOLVED: That the width of said rights-of-way shall be 40 feet, 50 feet on either side of the center line, the full length of the public highway;

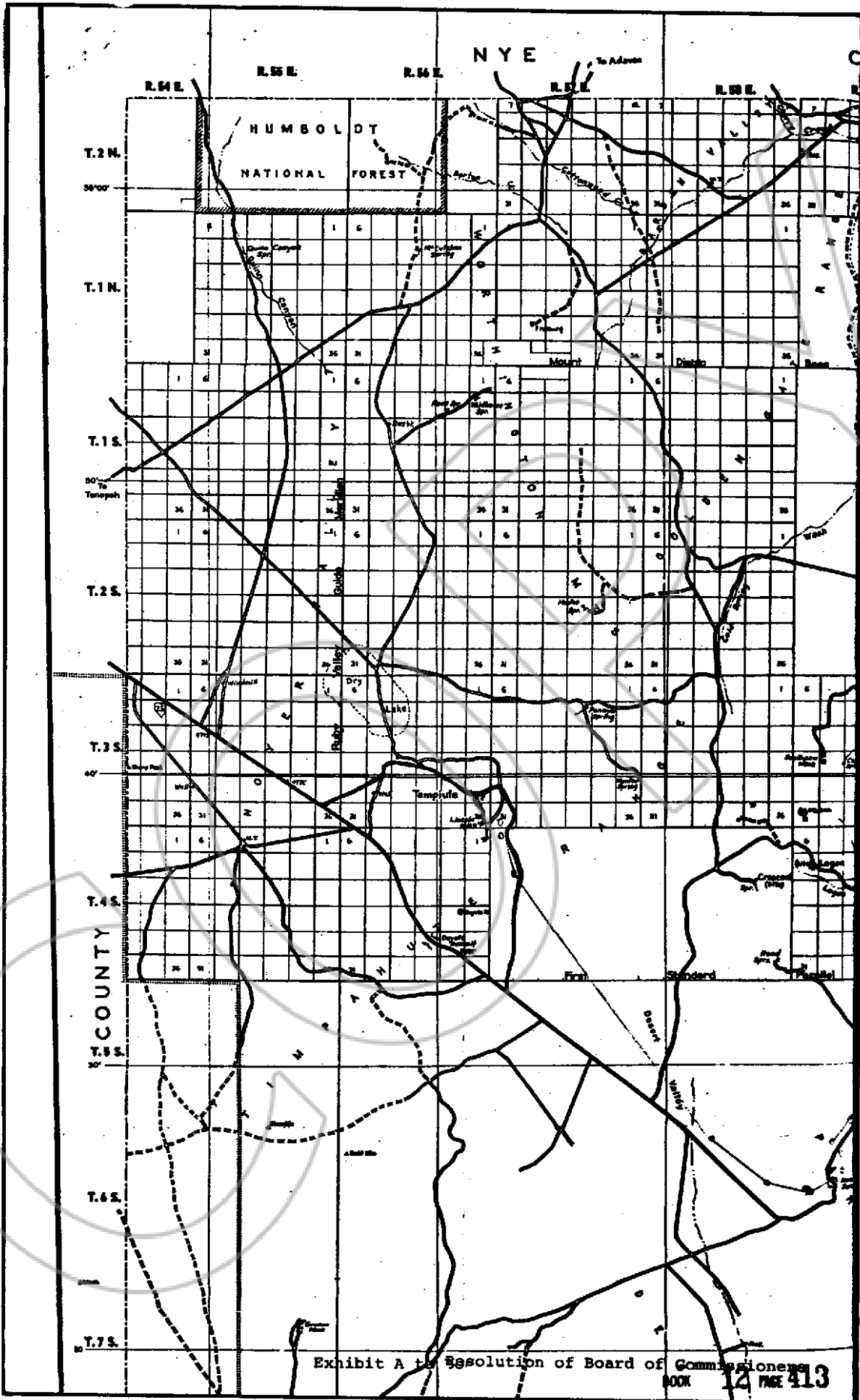
FURTHER RESOLVED: That the public highway within this right-of-way shall be known as the Tempiute Loop Road.

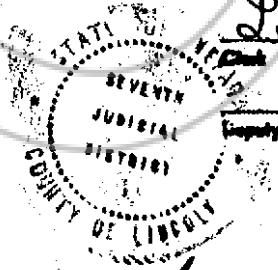
