ASSIGNMENT

THIS AGREEMENT made as of the 1st day of June, 1971, between TELEDYNE, INC., a Delaware corporation having an office at 1901 Avenue of the Stars, Los Angeles, California 90067 (hereinafter called "Teledyne") and UNION CARBIDE CORPORATION, a New York corporation having an office at 270 Park Avenue, New York, New York 10017 (hereinafter called "Union Carbide");

2. In the event that the lease agreement between Teledyne, Inc. and Union Carbide Corporation, made and effective as of February 15, 1968, is hereafter terminated as to all of the mining claims which are the subject of said lease, Union Carbide shall promptly resell, reassign, transfer and reconvey to Teledyne all of the right, title and incerest in the aforementioned Certificate of Appropriation of Water granted to Union Carbide by this agreement.
