

NOTICE OF LOCATION

(SECTS 2301 TO 2324. PUBLIC RESOURCES CODE)

TO WHOM IT MAY CONCERN: Please take notice that:

1. The name of this claim is the BORNITE NO 3 Lode Mining Claim. Said claim is situated in the Name UNKNOWN Mining District, County of LINCOLN, State of NEVADA. Located this 19th day of MARCH, 1975, when discovery was made and copy of the original notice posted.

2. That the undersigned locators are citizens of the United States or have declared their intention to become such, and have discovered mineral bearing rock in place thereon and do locate and claim same for mining purposes.

3. That the number of linear feet in length along the course of the vein each way from the point of discovery whereon we have erected a monument, is NORTH 750 feet, South 750 feet; that the total length does not exceed 1500 feet. That the width on the East side is 300 feet; that the width on the West side is 300 feet, that the total width does not exceed 600 feet, that the end lines are parallel; that the general course of the vein or lode as near as may be, is in a North and South direction; that the boundaries of this claim may be readily traced, and are defined as follows, to wit:
