Notice is hereby given that the undersigned locator, UNION CARBIDE CORPORATION, a New York corporation, whose post office address is 270 Park Avenue, New York, New York 10017, proprietor of numerous lode and placer mining claims in the Tempiute Mining District of Lincoln County, Nevada, and also proprietor of the Union Carbide Tungsten Reduction Plant to be erected in said District, has this day located five (5) acres of nonmineral ground, needed by the locator for mining, milling, processing, beneficiation and other operations in connection with its said claims and reduction plant, and to be used and occupied by the undersigned for such purposes. This millsite claim shall be known as Mike 278 Millsite Claim, and is situated in the Tempiute Mining District, County of Lincoln, State of Nevada, and being the Section _____, Township 3 South, Range 56 East, M.D.B. & M.

Beginning at corner No. 1 (NE), at which this notice is posted;

Thence west 330 feet to the south side center;
Thence west 330 feet to corner No. 3 (SW);
Thence north 330 feet to corner No. 4 (NW);

From corner No. 2 (SE) of the Mike 278 millsite claim the northeast corner of Section 21, T3S, R56E, M.D.B.&M. bears N 26°-18'W, 1,485 feet.
