TERMS AND CONDITIONS OF GRANT

Pursuant to the authority vested in the undersigned by Order No. 701 of the Associate Director, Bureau of Land Management, dated July 23, 1964 (29 F.R. 10526), a right-of-way, the details of which are shown above, is hereby granted, subject to the following terms and conditions:

1. All valid rights existing on the date of the grant.
2. All applicable regulations cited, including but not limited to 43 CFR 2801.1-5(m) which states: "That the right-of-way herein granted shall be subject to the express covenant that it will be modified, adapted, or discontinued if found by the Secretary to be necessary, without liability or expense to the United States, so as not to conflict with the use and occupancy of the land for any authorized works which may be hereafter constructed thereon under the authority of the United States."
3. Filing of proof of construction within ten years of the date of grant.
4. Compliance with Title VI of the Civil Rights Act of 1964 as contained in Appendix A attached hereto.
5. Permittee shall survey and clearly mark the exterior limits of the right-of-way. All activities directly or indirectly associated with the construction or maintenance of this right-of-way must be conducted within the limits thereof.
6. Permittee shall install a steel gate in addition to the cattle-guard at highway right-of-way station 10"676+40, as shown on Sheet 14 of 14 sheets of filed right-of-way maps.
7. The highway right-of-way shall be fenced with a 4-strand barbed wire, with bottom wire 18" off ground and other 3 strands 8" apart for a total of 42".
8. Back slopes shall be designed not to exceed grades 3 to 1, where possible. Slopes that do exceed these grades shall be serrated or terraced.
9. Minimize vegetation disturbance by clearing only the land needed for use and development purposes.
10. All garbage, debris and foreign matter shall be removed to an established dumpground.

11. When antiquities including, but not limited to, archaeological items, paleontological objects, or other objects of historic or scientific interest are discovered while using the property, the permittee shall leave the items or conditions intact, will immediately cease operations, and inform the District Manager, Ely District, Bureau of Land Management District, and should include the following:

- (a) The archaeological and historical values discovered on the subject lands must be evaluated and BLM, USDI, notified in writing prior to any highway or highway related construction activity on the subject lands, of the findings, evaluation of same, and finally a report on their significance.
- (b) A written statement must be submitted to BLM from the State Historic Preservation Officer stating what effect if any the proposed highway project will have on National Register of Historic Places sites or eligible National Register of Historic Places sites, before highway construction may commence or use of subject lands or materials therein utilized under any subject right-of-way grants made, or Free Use Permits issued by BLM.

Pursuant to 43 CFR 2801.1-5, the District Manager, Ely, Nevada, has the authority to conduct all business with the grantee with respect to use of lands and disposition of resources, and the grantee is requested to contact the above-designated official prior to the beginning of construction.

Appendix A

- (1) The grantee covenants and agrees that it will comply with provisions of Title VI of the Civil Rights Act of 1964, and that it will not, for the period during which the property conveyed by this instrument is used for highway purposes, or for another purpose involving the provision of similar services or benefits, engage in any discriminatory actions prohibited by 43 CFR 17.3, to the end that no person in the United States shall, on ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under the program for which the grantee received Federal financial assistance by this grant. This assurance shall obligate the grantee or in the case of transfer of the property granted herein, any transferee, for the period of this grant.
- (2) The grantee further agrees that it will not transfer the property conveyed by this instrument for the purpose designated in paragraph (1) hereof or for another purpose involving the provision of similar services or benefits, unless and until the transferee gives similar written assurance to the authorized officer, Bureau of Land Management, that it will comply with provisions of paragraph (1) hereof.
- (3) The grantee agrees that the right is reserved to the Department of the Interior to declare the terms of this grant terminated in whole or in part and to revert in the United States title to the property conveyed herein, in the event of a breach of the nondiscrimination provisions contained in paragraph (1) hereof during the term of this grant.
- (4) The grantee agrees that as long as property conveyed hereby is used for the purpose designated in paragraph (1) hereof, or for another purpose involving the same or similar services or benefits, the obligation to comply with the provisions of Title VI of the Civil Rights Act of 1964 shall constitute a covenant running with the land for the term of this grant.
- (5) The grantee agrees that in the event of a violation or failure to comply with the requirements imposed by paragraph (1), the United States may seek judicial enforcement of such requirements.
- (6) The grantee agrees, upon request of the Secretary of the Interior or his delegate, that it will post and maintain on the property conveyed by this document signs and posters bearing a legend concerning the applicability of Title VI of the Civil Rights Act of 1964 to the area or facility granted.


