

ASSIGNMENT

This indenture, made this 15 day of October, 1975, between JOHN BALLOW and RACHEL BALLOW of Caliente, <sup>Lincoln Co.</sup> ~~Nye~~ County, Nevada, ASSIGNOR, and SUMMA CORPORATION, a Delaware corporation, ASSIGNEE,

WITNESSETH:

That the said Assignor in consideration of the sum of TEN (\$10.00) DOLLARS, Lawful money of the United States of America, and other good and valuable consideration to them paid by the said Assignee, the receipt whereof is hereby acknowledged, do by these presents, assign and transfer unto the said Assignee, all the following described property situate and being in the County of Lincoln, State of Nevada, to wit:

1. All right, title, and interest of Assignor, or either of them in and to waters and grazing rights in the grazing allotment known as the Riggs Allotment, which includes interests in the following springs:

All right, title and interest of the Assignor, or either of them, in and to range or grazing privileges and water rights appurtenant thereto in the grazing allotment known as the Willow Creek Allotment, as allowed or allowable by the United States Bureau of Land Management. Said grazing privileges being 28 Class I Demand AUM'S (17 AUM'S Active) more or less. Said grazing privileges are transferred from the base property described as follows:
