# CERTIFICATE OF LOCATION

## LODE-QUARTZ

THIS IS TO CERTIFY that the YOUNG BLOOD NO I lode mining claim

was located by:

on the 30 day of MARCH, 1976, situated in the DELAKEAR MOUNTAINS  
UNKNOWN Mining District, UNKNOWN LINCOLN County, State of  
NEV., in Section UNKNOWN, Township 4, Range 65E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
vein, extending 750 feet from the location monument in a NORTHELY direction,  
and 750 feet in a SOUTHERLY direction, together with 300 feet on  
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a "STONE MONUMENT" feet high, inscribed "NW Corner  
of the YOUNGBLOOD NO I Claim;" the southwest corner is marked by a "STONE MONUMENT" feet  
high, inscribed "SW Corner of the YOUNGBLOOD NO I Claim;" the southeast corner is marked by  
a "STONE MONUMENT" feet high, inscribed "SE Corner of the YOUNGBLOOD NO I Claim;" the  
northeast corner is marked by a "STONE MONUMENT" feet high, inscribed "NE Corner of the  
YOUNGBLOOD NO I Claim." There is also a ROCK MONUMENT at the center of each side line.

The monumentation and marking of the corners was completed by the 2 day of APRIL, 1976.  
(to be filed within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
