

GRANT, BARGAIN AND SALE DEED

1 THIS INDENTURE made this 20 day of May, A.D., 1963, between GOTT-  
2 FREDSON'S DEPARTMENT STORE, a Partnership, of Caliente, Lincoln  
3 County, Nevada, as Grantor and DUANE JOHNSTON and MARY JOHNSTON,  
4 husband and wife, of Caliente, Lincoln County, Nevada, as Grantees.

5 WITNESSETH: That the said Grantor, in consideration of the sum of  
6 Five Dollars (\$5.00) lawful money of the United States of America  
7 and other and further valuable consideration to it paid by the  
8 said Grantees, the receipt whereof is hereby acknowledged, does by  
9 these presents, GRANT, BARGAIN and SELL unto the said Grantees,  
10 all that certain real property situate in and being in the City of  
11 Caliente, County of Lincoln, State of Nevada, described as follows:

12 All of Lots numbered Forty-five (45), Forty-six (46) and Forty-  
13 seven (47) of the Faulkner Tract, as shown on the Compiled Plat  
14 of the City of Caliente, filed on page 47 of the Official Plat  
15 Book in the office of the County Recorder of said County of Lin-  
16 coln, to which Plat reference is hereby made for further partic-  
17 ulars; together with any and all improvements thereon.

18 Also a strip of land lying on the west end of lots numbered For-  
19 ty-five (45), Forty-six (46) and Forty-seven (47) in Block num-  
20 bered Twelve (12) in the City of Caliente, County of Lincoln,  
21 State of Nevada, and more particularly described as follows:  
22 Commencing at the Northwest corner of Lot Forty-five (45); thence  
23 South along the west end lines of said lots Forty-five (45), For-  
24 ty-six (46) and Forty-seven (47) to the Southwest corner of lot  
25 Forty-seven (47); thence West a distance of Sixteen (16) feet;  
26 thence North a distance of Sixty-four (64) feet to a point; thence  
27 generally in a Northeasterly direction to the Northwest corner  
28 of Lot Forty-five (45), being the point of beginning.

29 TOGETHER WITH all and singular, the tenements, hereditaments and  
30 appurtenances thereunto belonging or in anywise appertaining, and  
31 the reversions, remainder or remainders, rents, issues and profits  
32 thereof.

33 TO HAVE AND TO HOLD all and singular the said premises, together  
34 with the appurtenances unto the said Grantees and their heirs and  
35 assigns forever.
