## LIFE ESTATE AND OPTION

In the event Grantor-Optionor shall receive a bona fide offer to purchase the demised premises during the term of this lease, and the offer of purchase shall be satisfactory to Granter-Optioner, Grantor-Optionor shall give Grantee-Optionee the privilege of purchasing the premises at the price and on the terms of the offer so made. This privilege shall be given by a notice sent to Grantee-Optionee at the demised premises by registered mail, requiring Grantee-Optionee to accept the offer in writing and to sign a suitable contract to purchase the premises within the period of Sixty days after the mailing of the notice. The failure of Grantee-Optionee to accept the offer to purchase or sign a contract within the period provided shall nullify and void the privilege of Grantee-Optionee, and Grantor-Optionor shall be at liberty to sell the premises to any other person, firm, or corporation. Any subsequent sale, except to Grantee-Optionee shall be subject to this life estate.
