## FOURTH SUPPLEMENTAL AGREEMENT

entered into this 26 day of July, 1976, by and between CALNEVA MINING COMPANY, a Nevada corporation (hereinafter designated "Calneva") and PRINCE CONSOLIDATED MINING COMPANY, a Utah corporation (hereinafter designated "Prince").

## WITNESSETH:

WHEREAS, Calneva, as "first party", and Prince, as "second party", mutually executed and delivered a certain Agreement dated April 7, 1937 pursuant to which Calneva granted to Prince the option to purchase certain property situated in the Ely Mining District, Lincoln County, State of Nevada, and which Agreement also leased to Prince said property for the purpose of extracting and shipping ores and minerals therefrom (hereinafter designated "Base Agreement"); and

WHEREAS, the Base Agreement was from time to time amended by certain modification agreements between the parties thereto and was terminated and superseded in its entirety by a certain Lease and Option Agreement dated August 1, 1947, between the parties thereto (hereinafter designated the "Lease and Option"); and

WHEREAS, the Lease and Option was supplemented and modified by Supplemental Agreements dated May 1, 1951, August 21, 1968 and June 9, 1972 between the parties thereto; and

WHEREAS, it is the desire of the parties to further amend and supplement the Lease and Option as hereinafter provided,

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency whereof are hereby acknowledged, it is agreed by and between the parties hereto as follows:

- The term of the Lease and Option and the time within which the option granted thereby may be exercised is hereby extended to and shall terminate on August 1, 1977.
- This Fourth Supplemental Agreement shall not be deemed to amend or modify the Lease and Option except as herein specifically provided.
- 3. This Fourth Supplemental Agreement is and shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
