 2 THIS INDENTURE made this 2nd day of September, 1976, between ROBERT

 4 Lincoln County, Nevada; HOWARD McCROSKY and LINDA McCROSKY, Hus-
 5 band and Wife, of Rose Valley, Lincoln County, Nevada; MAX McCROS-
 6 KY and SHIRLEY McCROSKY, Husband and wife, of Geysers, Lincoln
 7 County, Nevada; and WILLIAM L. McCROSKY and HOLLY McCROSKY, Hus-
 8 band and Wife, GORDON R. LYTLE and BETTY M. LYTLE, Husband and
 9 Wife, and KENNETH E. LYTLE and DONNA B. LYTLE, Husband and Wife,
 10 of Eagle Valley, Lincoln County, Nevada, as Grantors, and THE
 11 COUNTY OF LINCOLN, STATE OF NEVADA, as Grantee.

12 WITNESSETH that the said Grantors in consideration of the sum of
 13 Ten Dollars (\$10.00) lawful money of the United States of America
 14 and other and further valuable consideration, the receipt whereof
 15 is hereby acknowledged, do hereby release and forever QUITCLAIM
 16 unto the said Grantee and to its successors and assigns forever,
 17 all of the right, title and interest of Grantors in and to that
 18 certain real property situate, lying and being in the County of
 19 Lincoln, State of Nevada, and being a portion of the Southeast
 20 Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 35, Township
 21 2 North, Range 69 East, MDB&M, also being a portion of Lot 4 of
 22 the town of Ursine, County of Lincoln, State of Nevada, more par-
 23 ticularly described as:

24 Beginning at a point on the centerline of FAS 632, at Highway
 25 Engineer's Station "B" 2 + 87.44 P.T., said point further
 26 described as bearing N.81°53'05"E. a distance of 2384.84 feet
 27 from the southwest corner of Section 35, Township 2 North,
 28 Range 69 East, MDB&M, thence N.38°52'57"E. a distance of 24.75
 29 feet to a point; thence N.83°52'57"E. a distance of 42.00 feet
 30 to a point; thence S.38°52'57"W. a distance of 49.50 feet to
 31 a point; thence S.83°52'57"W. a distance of 42.00 feet to a
 32 point; thence N.38°52'57"E. a distance of 24.75 feet to the

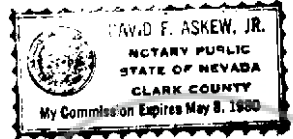
