CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Silverhorn No. 15 Lode Mining Claim in Section 4, Township 3 N., Range 65 E., M.D.B. & M. in the Bristol Mining District, in Lincoln County, State of Nevada, on the 10 day of August, 1976.

And further certifies that the above named claim was located for and in the name of B.F. Minerals Corp. & Harter & Company whose address is 900 Empire Life Bldg., Dallas, Texas 75201.

The claim is 1500 feet long and 600 feet wide, and 1450 feet is claimed in a Easterly direction and 50 feet in a Westerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The location of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate location by a scribed aluminum tag on each post.

All corners, sides, centers and locations are 4 X 4 wooden posts.

The monumentation and marking of the corners was completed by the 13 day of August, 1976.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
