

DEED OF CORRECTION

1
2 THIS INDENTURE made this 11 day of September, 1976, between
3 Q. E. FORTIER, H.D., formerly of the Town of Pioche, County of Lin-
4 coln, State of Nevada, as Grantor, and ROSE MARIE CONDIE, a single
5 woman of the Town of Pioche, County of Lincoln, State of Nevada, as
6 Grantee.

8 WITNESSETH that the said Grantor in consideration of the sum of Ten
9 Dollars (\$10.00) lawful money of the United States of America and
10 other and further valuable consideration, the receipt whereof is
11 hereby acknowledged, does hereby release and forever QUITCLAIM unto
12 the Said Grantee and to her heirs, successors and assigns forever,
13 all the right, title and interest of Grantor in and to that certain
14 real property described as:

15 All of the Southwest Quarter of the Southeast Quarter
16 of Section 34, Township 1 North, Range 69 East, Mt.
Diablo Meridian, containing 40 acres.

17 Also Lots 2 and 3 and the South Half of the Northwest
18 Quarter of Section 2, Township 1 South, Range 69 East,
Mt. Diablo Meridian, containing 117.79 acres.

19 Also all of the waters of Flat Nose Creek, the waters of
20 which have heretofore been used to irrigate the lands
21 above described; saving and excepting therefrom the
22 right to water not to exceed 3100 head of sheep, or
23 not to exceed 620 head of cattle, at what is commonly
24 known as the Sheep Pond Reservoir, which reservoir is
25 filled from the waters of Flat Nose Creek located at the
26 mouth of Gleason Canyon Wash and at a point where said
wash intersects with Flat Nose Wash in Lincoln County,
27 Nevada, and also reserving sufficient of the waters of
28 said Flat Nose Creek to keep said reservoir filled during
29 the period from October 15 to April 30 of each winter,
30 which said exception and reservations are reserved unto
31 John D. Hopkins and Ellen J. Hopkins and their heirs and
32 assigns.

33 TOGETHER WITH the tenements, hereditaments and appurtenances there-
34 unto belonging or in anywise appertaining, and the reversions, re-
35 mainders, rents, issues and profits thereof.

36 TO HAVE AND TO HOLD all and singular the said premises together with
37 the appurtenances unto the Grantee and her heirs, successors and
38 assigns forever.

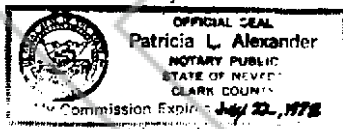
