CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Silverhorn No. 17 Lode Mining Claim in Section 33 & 4, Township 3 & 4 N, Range 65 E., M.D.B. & M., in the Bristol Mining District, in Lincoln County, State of Nevada, on the 19th day of November, 1976.

And further certifies that the above named claim was located for and in the name of B F Minerals Corp., and Harter & Company whose address is 900 Empire Life Building - Dallas, Texas 75201

The claim is 1500 feet long and 600 feet wide, and 1,490 feet is claimed in a Northwesterly direction and 10 feet in a Southeasterly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the Southeast to the Northwest.

The location of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate location by a scribed aluminum tag on each post.

At all corners, side centers and discovery monuments are 4"x 4"x 4 $\frac{1}{2}$ ' long wooden posts.

The monumentation and marking of the corners was completed by the 19th day of November, 1976.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
