NOTICE IS HEREBY GIVEN:

THAT The Federal Land Bank of Berkeley, being a federally chartered instrumentality of the United States existing under the provisions of the Farm Credit Act of 1971 (Public Law 92-181), is subject to supervision of the Farm Credit Administration, an independent agency in the Executive Branch of the Federal Government.

THAT the offices of the said bank have been removed from 2180 Milvia Street, Berkeley, California 94704, to 3636 American River Drive, Sacramento, California 95825.

THAT upon authority of an administrative order of the Farm Credit Administration, the charter of The Federal Land Bank of Berkeley has been amended pursuant to Sections 1.3 and 5.18(2) of the Farm Credit Act of 1971 (12 USC 2011 and 2252) to provide that the title of the said bank shall be FEDERAL LAND BANK OF SACRAMENTO and that its principal office shall be located in the County of Sacramento, State of California.

THAT the business formerly conducted by The Federal Land Bank of Berkeley has been succeeded to and is now being conducted by the Federal Land Bank of Sacramento; that the Federal Land Bank of Sacramento is liable for any and all obligations incurred by The Federal Land Bank of Berkeley, and is successor to any and all contractual rights of The Federal Land Bank of Berkeley; that the Federal Land Bank of Sacramento is empowered to reconvey, release, discharge or assign deeds of trusts, mortgages and other security instruments of whatever nature made in favor

of the Federal Land Bank of Berkeley or wherein The Federal Land Bank of Berkeley is named Trustee.
