

JOINT TENANCY DEED

THIS INDENTURE made this 27 day of April, 1977, between VERA ROWLEY, a widow, of 815 West 700 North, Salt Lake City, Utah, and LESLIE C. ROBERTS and LENA ROBERTS, Husband and Wife, of Milford, Utah, as Grantors, and IRA CLUFF and ELLA CLUFF, Husband and Wife, of 4141 Canal, Las Vegas, Nevada, as Joint Tenants with right of survivorship, as Grantees.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises together with the appurtenances unto the said Grantees as Joint Tenants and to the survivor of them and the heirs and assigns of such survivor forever.
