AMENDED LOCATION CERTIFICATE

THE UNDERSIGNED hereby certifies that he has located a mining claim in the Pahranaqat Mining District, County of Lincoln, State of Nevada.

The name of the claim is OWL # 72.

The general course of said lode or vein, as near as it may be described, is North to South.

The said claim was located on the 3 day of December, 1976, and the point of discovery, at which the location notice is posted, bears N82°E a distance of 11,070 ft. from the S.W. corner of Section 36, T. 3S, R. 58E, Mt. Diablo Base & Meridian.

From the discovery monument the undersigned claims 50 feet in a Southerly direction, and 1450 feet in a Northerly direction, and 300 feet on each side of the middle of the claim. The claim is 600 feet wide and 1500 feet long.

The surface boundaries of the claim are marked upon the ground as follows: Beginning at the discovery monument (a post on which the location notice is posted), thence 50 feet in a Southerly direction to the South center end of the claim, thence 300 feet in a Westerly direction to monument No. 1, a post marked S.W. cor. OWL # 72, thence 750 feet in a Northerly direction to monument 2, a post marked West side center OWL # 72, thence 750 feet in a Northerly direction to monument No. 3, a post marked N.W. cor. OWL # 72, thence 600 feet in a Easterly direction to monument No. 4, a post marked N.E. cor. OWL # 72, thence 750 feet in a Southerly direction to monument No. 5, a post marked East side center OWL # 72, thence 750 feet in a Southerly direction to monument No. 6, a post marked S.E. cor. OWL # 72, thence 300 feet in a Westerly direction to the South center end of the claim, thence to the point of beginning.

Location work for this mining claim consisted of preparing a map of said claim as provided in Section 517.040 of the Nevada State Mining Laws, 1972 edition.
