Witnesseth: That Trustor IRREVOCABLY GRANTS, TRANSFERS AND ASSIGNS TO TRUSTEE IN TRUST, WITH POWER OF SALE, that property in Lincoln County, Nevada, described as:

LOT TWENTY-THREE (23) AND THE NORTHERLY TWELVE (12) FEET OF LOT TWENTY-FIVE (25) IN DENTON HEIGHTS, IN THE CITY OF CALIENTE, NEVADA
