9 ORDER SETTING ASIDE ESTATE

10 IT APPEARS to the satisfaction of the Court that a verified peti-  
11 tion has been filed and notice of the hearing thereon has been  
12 duly given and all the sons and daughters of the decedent have  
13 waived any and all interest in said estate; the Court finds that  
14 the net value of the whole estate does not exceed the sum of Ten  
15 Thousand Dollars (\$10,000.00); and Good Cause Appearing Therefor:

16 IT IS ORDERED:

- 17 1. That the Estate of CLINTON T. SHIPMAN, Deceased, be not  
18 administered upon and that the whole thereof be assigned and set  
19 apart to EDNA U. HANNIG, formerly EDNA U. SHIPMAN, widow of dece-  
20 dent.
- 21 2. That one-half of the community property vested, by opera-  
22 tion of law, in EDNA U. HANNIG, as widow of decednet, at decedent's  
23 death, and that by virtue of such vesting, as regards the commun-  
24 ity property, the community property interest of one-half belong-  
25 ing to decedent's estate is hereby vested in petitioner and the en-  
26 tire of said property is hereby declared to be the sole and separ-  
27 ate property of EDNA U. HANNIG.
- 28 3. Said real property is described as follows:  
29 Lot Five (5), Block Thirty-one (31), in the Town of Pioche,  
30 County of Lincoln, State of Nevada, together with any and all  
31 improvements situate thereon.
- 32 4. That a certified copy of this Order be recorded with the

1 County Recorder of Lincoln County, Nevada.

2 5. That the remainder of decedent's estate be, and the same  
3 is hereby, assigned and set aside without administration to EDNA  
4 U. HANNIG as her sole and separate property.
