EXHIBIT "A"

Geological mapping consisting of 24 man hours during August, 1977 was accomplished by HOUSTON OIL AND MINERALS CORPORATION personnel on the Blue Nose Claims Nos. 40, 41, 42 and 43. The work consisted of surveying (see accompanying map) by compass, and tape and recording the nature of the rock and soil at each sample station.

Concomitant geochemical sampling was also accomplished as the geology was mapped. Approximately 31 samples were collected at sample sites (see accompanying map) and sent to Skyline Laboratory, Denver, Colorado for analysis.

The work indicates the presence of shallow shelf limestone rock.
