7 coln County, Nevada, as Grantees.

8 WITNESSETH: That the said Grantors in consideration of the sum
9 of Ten Dollars (\$10.00) lawful money of the United States of
10 America and other and further valuable consideration, the re-
11 ceipt whereof is hereby acknowledged, do by these presents,
12 GRANT, BARGAIN and SELL unto the said Grantees and to their
13 heirs and assigns forever. all of the right, title and interest
14 of Grantors in and to that certain real property situate in the
15 City of Caliente, County of Lincoln, State of Nevada, and des-
16 cribed as follows:

17 The Best One-Half (1/2) of Lot numbered Nine (9)
18 and all of Lots numbered Ten (10), Eleven (11),
19 and Twelve (12) in Block numbered Fourteen (14)

21 of Nevada, as said lots and block are delineated

23 of Caliente now on file and of record in the Of-
24 fice of the County Recorder of Lincoln County,
25 Nevada, together with any and all improvements
26 thereon, consisting of a dwelling-house, eight
27 motel units, a storeroom and shed.

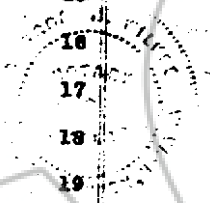
